The Ministry of Labour & Social Security intends to engage a firm for the provision of professional services to establish a robust system for the recovery of scholarship loans from all past beneficiaries of the pre-service tertiary education scholarship fund and also to develop the most efficient means of collecting loans from future beneficiaries and capacitating the scholarship secretariat to ensure continuity.

The Ministry of Labour & Social Security invites qualified firms to express their interest in providing the above mentioned services. The Expression of Interest document can be obtained at Ministry of Labour & Social Security, National Employment Services Department, 3<sup>rd</sup> Floor, Inter-Ministerial Building, Mbabane, Swaziland for the price of E300 (three hundred Emalangeni), which, against receipt, should be paid at Mbabane Revenue Office under 401/1806/22103. Firms may associate to enhance their qualifications

The key requirements for the staff to be involved in service are:

- Accounting skills
- Legal skills
- Computer Systems development and management skills

The evaluation will follow the Public Procurement Regulations, 2008, be competitive, and result in a 'short listing' of firms. Following this process, it is the intention to invite the short listed firms to provide proposals for the requested services.

You are requested to fill in the Expression of Interest document, sign the Declaration (Section 1.7), and sign the Statement. All shall be deposited in the Treasury Tender Box situated at the address below by 9.00 a.m. on 16 December 2011. Late applications will not be considered.

#### INFORMATION ON THE REQUIRED SERVICES

The programme will be fully funded by Government, whose responsibility is to ensure an effective recovery system for scholarship loans and the establishment of a revolving fund; which will be used to fund the programme in future. The Ministry is looking for a competent and reputable company to provide the following services:

Administrative and systems development:

- 1) Review the quality of the existing database and upgrade it to provide relevant and accurate information;
- 2) Design the most efficient collection mechanism for recovering funds from current debtors;
- 3) Review existing administrative procedures for the award and recovery of loans from past beneficiaries:

- 4) Review the institutional framework for the award of scholarships under the Fund;
- 5) Review the operational manuals used by the Ministry and the Scholarship Secretariat; and
- 6) Train all relevant staff on the new system.

### Legal:

- 7) Review existing legislation to eliminate loopholes which prevent enforcement of contractual provisions and advise on necessary improvements to make the scholarship award and recovery process robust;
- 8) Review and develop if necessary, an enabling legal framework for the award Pre-Service Tertiary Education Scholarships;
- 9) Develop the necessary legal framework for establishing a Revolving Loan Fund; and
- 10) Review scholarship agreement documentation and recommend improvements.

#### Accounting:

- Review and revise as necessary, accounting procedures for payment of loans to beneficiaries, and beneficiary tertiary institutions;
- 12) Determine how much is owed by individual past beneficiaries; and
- 13) Determine and define as possible, the role of beneficiary institutions in facilitating the recovery of scholarships from past beneficiaries

A detailed outline of the entire team that will be working on the project is also required, along with their Curriculum Vitae and an indication of the duties that will be carried out by each member.

#### EVALUATION CRITERIA OF THE EXPRESSION OF INTERESTS

There is a public opening of the Expression of Interests. The evaluation will be conducted by an Evaluation Committee with the purpose of developing a short list of firms, which later is expected to be invited to provide proposals for the required services.

The Expression of Interests will at first be evaluated based on the following Evaluation Criteria:

- Eligibility is fulfilled, which means that:
  - The five mandatory documents to be attached to the Expression of Interest as Appendices must fulfil the requirements, and
  - There is a satisfactory signed Declaration of Eligibility for each participating firm (Section 1.7).
- The financial standing of the firm is satisfactory (Section 1.3).

All firms, which fulfil the above criteria, will then be evaluated and ranked based on an evaluation of:

- That the number of staff resources is considered satisfactory in regard to the services to be performed (Section 1.4).
- That the experiences of relevant staff are considered satisfactory in regard to the services to be performed (Section 1.5).
- That the firm can show sufficient earlier experience in regard to the services to be performed (Section 1.6).

#### PREFERENCE OF PROPOSALS FROM SWAZI COMPANIES

In the evaluation of the proposals for the consultancy services, 10 evaluation points (out of 100 points) will be allocated for participation by Swazi companies or nationals during the technical evaluation of the proposals.

#### SIGNING OF THE EXPRESSION OF INTERESTS

The Expression of Interest shall be signed by the Applicant. If not, it will be rejected.
